

Interviewing Techniques for Auditors & Inspectors

Since 1982, Wicklander-Zulawski & Associates, Inc (WZ) has provided training to a large majority of local, state and federal law enforcement agencies. This course is designed to enhance interviewing skills to better prevent and detect fraud. Instruction consists of behavioral analysis, non-confrontational interview techniques, fraud indicators, methods to assess fraud vulnerability, techniques to overcome objections, and how to elicit relevant information and actionable intelligence.

Seminar participants learn to assess verbal and non-verbal behavior and become more effective at obtaining information in person, as well as via telephonic interviews. Instruction consists of non-confrontational interview techniques to overcome resistance, offer rationalizations, detect deception and evaluate truthfulness. Additionally, the techniques taught within this program will enhance their skills to uncover other dishonest or unlawful activities that may or may not be related to the primary investigation.

Attendees are taught specific questions that can and should be used in every audit interview. These questions are uniquely structured, non-accusatory, non-threatening, information gathering, and designed to identify indicators of fraud. Instruction is provided on how these questions can flow naturally in the interview process, without undermining the overall objective of the audit.
