# Tools of the Trade: Mastering Each Method

When it comes to home improvement or fixing a car we all are well aware that multiple tools are needed to get the job done efficiently and effectively. Using the wrong tool may delay the process or result in even further



damage. This same rule applies to interviewing methods, an important toolbox for any investigator. It is essential that investigators are aware there are many tools at their disposal when it comes to the interview or interrogation process. More importantly, investigators must utilize the proper methods based on the type of available evidence, background of the subject and other surrounding variables of the case. The misapplication of a method or inappropriate selection may hamper the investigators ability to obtain the truth and also result in a confirmation bias of the investigator. 
